We reserve the right to block or delete your account/terminate service without giving you any notice in case we detect violation of these terms, unlawful actions, misuse or abuse of the app and/or app servers.

The Lords Of The Galaxy app stores and processes personal data that you have provided to us, in order to provide our Service (more information in Privacy Policy). It's your responsibility to keep your phone and access to the
